

THIS DECLARATION OF TRUST is made this Fifth day of September One thousand nine hundred and forty nine by (1) KRISHNA KUMAR BIRIA son of Ghanshyandas Birla Hindu Merchant of No.8, Royal Exchange Place in the town of Calcutta (2) KESHAVDEO JALAN son of Banshidhar Jalan deceased Hindu Merchant of No.61, Harrison Road in the town of Calcutta (3) BHAGIRATHMAL KANORIA son of Ramdutt Kanoria deceased Hindu Merchant of No.8, Royal Exchange Place in the town of Calcutta (4) RAMESHWAR LALL NOPANY son of Daulatram Nopary deceased Hindu Merchant of No.178, Harrison Road in the town of Calcutta (5) GANGA PRASAD BUDHIA son of Ganpatroy Budhia deceased Hindu Merchant of Ranchi in Bihar and (6) KALI CHARAN BHAGAT son of Ghanshyandas Bhagat Hindu Merchant of No.15, Shib Thakur Lane in the town of Calcutta hereinafter jointly referred to as the "FOUNDERS"

WHEREAS the founders have collected from amongst themselves and others a total sum of Rs.30,000/- (Rupees Thirty thousand) inter alia with a view to start and run a residential public school for imparting education.

AND WHEREAS the founders intend to collect further monays for the purpose aforesaid.

AND WHEREAS the founders desire to constitute a trust for the said sum of Rs.30,000/- (Rupees Thirty thousand) and all other sums that may hereafter be collected by or through them or other persons for the purpose aforesaid.

AND WHEREAS the founders have agreed to act as the FIRST TRUSTEES of the said trust.

NOW FOR EFFECTUATING THE SAID DESIRE this Deed witnesseth as

The Trustees hereby jointly do and each of them severally doth hereby declare that they will henceforth stand possessed of the said sum of Rs.30,000/- (Rupees Thirty thousand) and all collections and donations that may from time to time hereafter be made by them or other persons in trust for the uses and purposes and subject to the rules and regulations hereinafter mentioned.

1. The Trust shall be called "THE MANAVA VIKAS VIDYALAYA TRUST".
2. The Head Office of the Trust will be situated at Calcutta in the province of West Bengal with local offices at such place or places as the Trustees may from time to time decide. The Trustees will also be entitled from time to time to transfer the Head Office and/or local offices of the Trust to any place in the Indian Union.
3. In this document unless there is anything repugnant to or inconsistent with the subject or context the following words shall have the meaning hereby assigned to them :-

- (i) The Trust means "THE MANAV VIKAS VIDYALAYA TRUST".
- (ii) The Trustee means Trustees for the time being of the Trust.
- (iii) The Trust properties shall means trust properties of whatever nature and kind held by the Trustees in terms of these presents and shall include the said sum of Rs.30,000/- and/or any other sum or sums that the Trustees may collect or receive from other persons for the objects of the Trust and shall include other rights and privileges belonging to the Trust.

4. The objects of the Trust shall be

- (a) To found and run a residential public school in the District of Ranchi in the province of Bihar and/or at other places in the Indian Union with objects inter alia to impart to the students of the said school, literary, scientific, ^(3rd page) technical, industrial, religious, physical and other kinds of education including practical training for manufacture and assembling of

(b) To establish, acquire, run and aid schools, colleges, libraries, reading rooms, hostel, boarding houses, laboratories and other institutions at any place or places in the Indian Union for use of the students and staff of the public school established or run by the Trust and generally for diffusion of knowledge among the public.

(c) To establish, maintain, and/or grant studentship, scholarships and other kinds of aid to deserving students including supply of books, stipends, medals and other incentives to study and to provide board and residence for them.

(d) To establish, run and aid gymnasiums, akharas, sporting clubs, physical culture homes and other like institutions for the use of the students and staff of the institutions established and/or run by the Trust and generally for the use of the public.

(e) To establish, maintain and grant-in-aid to hospitals, medical schools, medical colleges, nursing institutions, sanatorium, travelling dispensaries, after-care clinics or other similar institutions for the benefit of the students and staff of the institutions established and/or run by the Trust and for the use of the public in general.

(f) To do all other acts deeds and things and objects of general public utility as may be necessary or deemed expedient to carry out all or any of the objects aforesaid.

5. The Trustees may accept any donations or contributions in cash or kind from any person or persons, firm, body corporate or incorporate for the furtherance of the objects of the Trust or anyone or more of

Then as they may in their absolute discretion think fit but not inconsistent in any manner with ^{(bik bnd) link} any of the aforesaid objects of the Trust. In particular the Trustees may enter into an arrangement with the Ranchi Goshala at Ranchi and acquire on lease or on other terms land belonging to the said Ranchi Goshala situate in the district of Ranchi on such terms and conditions as may be agreed upon between the Trustees and authorities of the said Ranchi Goshala and to make it one of the conditions of such agreement that the said Ranchi Goshala would be entitled to nominate one trustee in the Board of Trustees hereinafter as long as the Trust utilises the land of the said Goshala for any of the objects of the Trust.

6. The Trustees may also take up the management of any other institutions having objects fully or in part similar to those of the Trust and may manage and run such institutions.

7. For the purposes of carrying out of the objects of the Trust, the Trustees by a resolution passed by a majority of two third of their number, shall be entitled to carry on such businesses as they may think fit from time to time and to close and re-start any of such businesses provided that all such businesses shall be carried on upon trust and if any capital is derived from the business carried on, on behalf of the trust it shall be applied solely to the purposes of the Trust and the businesses a-re carried on in the course of the carrying out of all or any of the purposes and objects of the Trust or such business is mainly carried on by the beneficiaries of the institution or institutions run and maintained by the Trust and for the purposes of carrying out such businesses the Trustees shall be entitled to do all acts, matters and things which may be necessary to do in carrying such businesses.

The Trustees shall cause true and accurate accounts to be kept of all moneys received and spent and of all matters in respect thereof in course of management of Trust Properties or in relation to the carrying out the objects and purposes of the Trust as well as of all the assets, credits and effects of the Trust Properties.

9. The Trustees shall, from time to time, after meeting the expenses of and incidental to the management of the Trust Properties and of the Trust, decide the particular object or objects for which the income or corpus of the Trust Properties for the time being available shall be applied.

The Trustees may invest the Trust Fund either in the purchase or mortgage of immovable property or in such investments whether authorized by the Indian Trust Act, 1882 or not, on such terms as to interest as the Trustees may think proper with power to the Trustees to alter vary or transpose such investments from time to time in such manner, as they may in their absolute discretion think fit, for others of the same or of a like or different nature. Provided however that except with the consent of all the Trustees, no portion of the Trust Fund shall be kept in deposit with any of the Trustees or any firm or any company in which any of the Trustees shall be interested.

11. The Trustees may from time to time open, close and maintain in the name of the Trust banking account or accounts and may operate the same by authorising any or more of them from time to time as they think best but in case any bank is not willing to open and maintain any banking account in the name of the Trust, then only the account or accounts may be opened in the name or names of one or more Trustees as may be decided by the Board of Trustees from time to time for operating

the said account. All securities investment title deeds and other documents relating to the Trust Estate and not immediately required by the Trustees shall be kept for safe custody with the Bankers of the Trust.

12. The Trustees shall be at liberty to sell such portion or portions of the movable or immovable properties forming part of the Trust Fund either by public auction or by private contract at such price or prices and on such terms and conditions relating to title or otherwise in all respects as they may in their absolute discretion think fit and to buy in, rescind or vary any contract for the sale thereof and to resell the same without being answerable for any loss occasioned thereby and for that purpose to execute all necessary conveyances, transfers or other assurances and to pass valid and effectual receipts and discharges for all moneys received by them. 18/11/18

13. The Trustees may by the consent of a majority of them raise or borrow money required for the purposes of the Trust on a mortgage or pledge of the Trust Properties or any part thereof or without any security and at such rate of interest and on such terms as they may in their absolute discretion think fit. Provided however that the amount of such borrowed money should not exceed Rs. 50,000/- (Rupees fifty thousand) only at any time.

14. The Trustees may pay all charges and outgoings payable in respect of any immovable property for the time being forming part of the Trust Fund and may carry out repairs required to be done to the same and keep the same insured against loss or damage by fire and may incur all other costs charges and expenses of and incidental to the administration and management of the Trust Estate and the properties for the time being belonging to the Trust as they may in their absolute discretion think fit.

15. The Trustees may demise the immovable property or properties for the time being and from time to time belonging to the Trust either from year to year or for any less terms or for any term of years or on monthly tenancies at such rent and subject to such covenants and terms as they may think profit and also accept surrenders of leases and tenancies and generally manage the same in such manner as they think proper.

16. The Trustees shall have full powers to compromise or compound all actions, suits and other proceedings and all differences and disputes touching the Trust Estate and/or the Trust Properties and to refer any such differences or disputes to arbitration and to adjust and settle all accounts relating to the Trust Estate and/or the Trust Properties and to do all other acts and things as fully and effectually as if they were absolutely entitled to the Trust Estate and Trust Properties, without being liable or answerable for any loss occasioned thereby.

17. The Trustees may join, co-operate and by the consent of all of them amalgamate the Trusts of these presents or any portion thereof with any Trust or institutions having allied or kindred objects upon such terms as they may in their absolute discretion think fit.

18. The Trustees may from frame schemes and rules and regulations for the carrying out of the objects of the Trust and for the proper and better management and running of any institutions established, run or aided by them and for managing the affairs of the Trust and otherwise for giving effect to the objects and purposes of the Trust and to vary, add to, alter or repeal the same from time to time as the Trustees may in their absolute discretion deem fit and proper. Provided however that the aims and objects of the Trust shall not be varied or amended in any manner.

19. The Trustees shall be entitled at their discretion from time to time to start, discontinue, abolish and re-start any charity or charitable institutions, to impose any condition or conditions to any subscription or donation made by them and to earmark any portion of the Trust Property or income for any particular object or objects.

20. The receipt of the Trustees for any moneys, stocks, funds, shares, securities or investments paid, delivered or transferred to them in execution of the trusts or power thereof shall effectually release and discharge the person or persons, paying delivering or transferring the same, therefrom and from seeing or from being bound to see to the application or being answerable for the loss or misapplication thereof.

21. The Trustees shall be respectively chargeable only for such moneys, stocks, shares, funds and securities as they shall actually receive notwithstanding their respectively signing a receipt jointly with others for the sake of conformity and shall be answerable and accountable for their own accounts, receipts neglects and defaults respectively and shall not be answerable, one for the other or others of them, nor for any banker, broker or other person with whom or into whose hands any trust moneys or securities may come or be deposited or given nor for the insufficiency or deficiency of any stocks, shares, funds or other securities nor for any other loss unless the same shall happen through their wilful default or negligence respectively.

The Trustees may reimburse themselves and pay and discharge out of the Trust Fund all expenses incurred in or about the execution of the trusts or any of their duties under these presents.

23. The surviving or continuing trustees may act notwithstanding any vacancy in their body PROVIDED HOWEVER that if the number of Trustees shall fall below five, the minimum fixed by these presents, the Trustees

shall not except for the purpose of filling any vacancy act so long as the number is below the said minimum.

24. The Trustees shall be entitled to appoint one of them as Chairman of the Board of Trustees for such period as they think fit. The Chairman shall preside at the meetings of the Trustees and exercise such powers as may from time to time be delegated to him.

25. Three Trustees shall form a quorum for any meeting of the Trustees. A meeting of the Trustees at which a quorum is present shall be entitled to exercise all or any of the powers vested in the Trustees under these presents or in law.

26. If ^{at} any meeting the Chairman is not present within fifteen minutes of the time appointed for the meeting of the Trustees present shall choose one of themselves to be the Chairman of such meeting.

27. All questions arising at the meeting of the trustees shall be decided by a majority of votes and in case of equality of votes, the Chairman shall have a second or casting vote.

28. The Trustees may delegate any of their powers to any person or to a Committee consisting of such person or persons whether member of their body or not, as they think fit.

29. A competent auditor shall be appointed for auditing accounts of income and expenditure of the Trust. The auditor shall be appointed by the Board of Trustees only for one year.

30. A resolution in writing circulated amongst all the Trustees and passed by a majority of the Trustees shall be as valid and effectual as if it had been passed at a meeting of the Trustees duly called and convened.

36. The number of the Trustees shall not be less than five or more than eleven.
37. A person shall cease to be a Trustee in any of the following events:
- (a) if he dies;
 - (b) if he without leave of absence does not attend three consecutive meetings of the Trustees or for one calendar year whichever is lower;
 - (c) if he becomes bankrupt; or
 - (d) if he becomes insane or otherwise becomes incapable to act;
